1. THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER JUNE 2, 1992, NOTICE OF ITS ANTIDUMPING DUTY ORDER ON FRESH KIWIFRUIT FROM NEW ZEALAND.

2. THE PRODUCT COVERED BY THIS ORDER IS FRESH KIWIFRUIT. PROCESSED KIWIFRUIT, INCLUDING FRUIT JAMS, JELLIES, PASTES, PUREES, MINERAL WATERS, OR JUICES MADE FROM OR CONTAINING KIWIFRUIT, ARE NOT COVERED UNDER THE SCOPE OF THIS INVESTIGATION. THE SUBJECT MERCHANDISE IS CURRENTLY CLASSIFIABLE UNDER SUBHEADING 0810.90.20.60 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

ALTHOUGH THE HTS NUMBER IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, OUR WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-614-801.

4. BLUE LINE REPORTS ARE REQUIRED FOR WAREHOUSE WITHDRAWALS FOR CONSUMPTION.

5. FOR EXPORT OF FRESH KIWIFRUIT FROM NEW ZEALAND BY THE NEW ZEALAND KIWIFRUIT MARKETING BOARD AND ALL OTHER COMPANIES, THE CUSTOMS SERVICE SHALL ASSESS ANTIDUMPING DUTIES ON ALL ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

NOVEMBER 27, 1991. CUSTOMS OFFICERS MUST REQUIRE, AT THE SAME TIME AS IMPORTERS WOULD NORMALLY DEPOSIT ESTIMATED DUTIES, THE FOLLOWING CASH DEPOSITS FOR THE SUBJECT MERCHANDISE:
