1. ON FEBRUARY 27, 1992, THE DEPARTMENT OF COMMERCE
AND THE VENEZUELAN PRODUCERS/EXPORTERS OF GRAY PORTLAND
CEMENT AND CLINKER SIGNED AN AGREEMENT SUSPENDING THE
ANTIDUMPING INVESTIGATION ON THAT MERCHANDISE. THE
EFFECTIVE DATE OF THE AGREEMENT IS FEBRUARY 27, 1992.
(THE DATE OF PUBLICATION IN THE FEDERAL REGISTER)

2. ON MARCH 11, 1992, THE DEPARTMENT OF COMMERCE AND THE

GOVERNMENT OF VENEZUELA SIGNED AN AGREEMENT SUSPENDING THE COUNTERVAILING DUTY INVESTIGATION ON GRAY PORTLAND CEMENT AND CLINKER FROM VENEZUELA. THE EFFECTIVE DATE OF THE AGREEMENT IS MARCH 17, 1992. (THE DATE OF PUBLICATION IN THE FEDERAL REGISTER).

3. ACCORDINGLY, FOR SHIPMENTS OF THE SUBJECT MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER MARCH 17, 1992, YOU SHALL NOT SUSPEND LIQUIDATION FOR ANY VENEZUELAN PRODUCERS/EXPORTERS. IF YOU HAVE SUSPENDED LIQUIDATION ON ANY ENTRIES OF THIS MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE ON OR AFTER MARCH 17, 1992, PLEASE REFUND THE AMOUNT OF ANY CASH DEPOSIT OR BOND.
4. FOR SHIPMENT OF THIS MERCHANDISE FROM VENEZUELA ENTERED BETWEEN AUGUST 21, 1991 AND MARCH 16, 1992, FOR WHICH BOND WAS POSTED OR CASH DEPOSITS COLLECTED, YOU SHALL REFUND THE AMOUNT OF ANY CASH DEPOSITS OR BOND AND LIQUIDATE WITHOUT REFERENCE TO DUTIES.
