2. FOR SHIPMENTS OF SWEDISH STAINLESS STEEL HOLLOW PRODUCTS  
ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

MAY 20, 1992, YOU SHALL COLLECT A CASH DEPOSIT EQUAL TO THE AMOUNT LISTED BELOW:

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.

5. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL YOU RECEIVE APPRAISEMENT INSTRUCTIONS. INSTRUCTIONS MAY BE DELAYED INDEFINITELY IF AN APPEAL OF THE FINAL IS FILED WITH THE COURT OF INTERNATIONAL TRADE.
