1. IN ACCORDANCE WITH EMAIL 2034116, NO CASH DEPOSITS OR BONDS
FOR POTENTIAL COUNTERVAILING DUTIES WILL BE REQUIRED FOR
MERCHANDISE WHICH ENTERS ON OR AFTER APRIL 28, 1992. THE
SUSPENSION OF LIQUIDATION FOR COUNTERVAILING DUTY PURPOSES WILL
NOT BE RESUMED UNLESS AND UNTIL THE DEPARTMENT OF COMMERCE
PUBLISHES A COUNTERVAILING DUTY ORDER. FURTHERMORE, CUSTOMS
SHOULD HOLD ANY ENTRIES SUSPENDED BETWEEN DECEMBER 30, 1991, AND
APRIL 27, 1992, UNTIL THE CONCLUSION OF THIS INVESTIGATION.

2. HOWEVER, PLEASE NOTE THAT IN ACCORDANCE WITH EMAIL #2125112, LIQUIDATION SHOULD CONTINUE TO BE SUSPENDED FOR ANTIDUMPING PURPOSES AND THE BOND OR DEPOSIT SPECIFIED IN EMAIL #2125112 SHOULD CONTINUE TO BE REQUIRED.

3.
