INSTRUCTIONS WILL NOT BE SENT UNTIL AT LEAST 30 DAYS AFTER PUBLICATION OF THE FINAL RESULTS, AND MAY BE DELAYED INDEFINITELY IF AN APPEAL OF THE FINAL RESULTS IS FILED WITH THE COURT OF INTERNATIONAL TRADE.
