ON 05/01/2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601), MANUFACTURED OR EXPORTED BY PEER BEARING COMPANY - CHANGSHAN (CPZ) FOR THE PERIOD 06/01/2000 THROUGH 01/31/2001.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY CPZ AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 06/01/2000 THROUGH 01/31/2001. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
