1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON BRASS SHEET AND STRIP FROM CANADA (A-122-601) FOR THE JANUARY 1, 1990 THROUGH DECEMBER 31, 1990 PERIOD AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON MAY 13, 1992.

2. IMPORTS COVERED BY THIS REVIEW ARE SHIPMENTS OF BRASS SHEET

AND STRIP, OTHER THAN LEADED BRASS AND TIN BRASS, FROM CANADA. THIS MERCHANDISE IS CLASSIFIABLE UNDER ITEM NUMBERS 7409.21.00 AND 7409.29.00 OF THE HARMONIZED TARIFF SCHEDULE (HTS). THE CHEMICAL COMPOSITIONS OF THE PRODUCTS UNDER REVIEW ARE CURRENTLY DEFINED IN THE COPPER DEVELOPMENT ASSOCIATION (CDA) 200 SERIES OR THE UNIFIED NUMBERING SYSTEM (UNS) C2000 SERIES. PRODUCTS WHOSE CHEMICAL COMPOSITIONS ARE DEFINED BY OTHER CDA OR UNS SERIES ARE NOT COVERED BY THIS ORDER.

THE PHYSICAL DIMENSIONS OF THE PRODUCTS COVERED BY THIS ORDER ARE BRASS SHEET AND STRIP OF SOLID RECTANGULAR CROSS SECTION OVER 0.006 INCHES (0.15 MILLIMETERS) THROUGH 0.188 INCHES (4.8 MILLIMETERS) IN FINISHED THICKNESSES OR GAUGE, REGARDLESS OF WIDTH. COILED, WOUND ON REELS (TRAVERSE WOUND), AND CUT-TO-LENGTH PRODUCTS ARE INCLUDED.

3. ACCORDINGLY, FOR SHIPMENTS OF BRASS SHEET AND STRIP MANUFACTURED BY WOLVERINE TUBE (CANADA) INC. (A-122-601-004), WHICH ARE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 13, 1992, A CASH DEPOSIT OF 21.32 PERCENT IS REQUIRED. THE CASH DEPOSIT FOR OTHER PREVIOUSLY

REVIEWED OR INVESTIGATED COMPANIES IS THE RATE PROVIDED IN THE AD/CVD MODULE. FOR ALL OTHER MANUFACTURERS OR EXPORTERS, THE CASH DEPOSIT REQUIRED IS ZERO.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW.
5. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL APPRAISEMENT INSTRUCTIONS ARE ISSUED. INSTRUCTIONS WILL NOT BE SENT UNTIL AT LEAST 30 DAYS AFTER PUBLICATION OF THE FINAL RESULTS, AND MAY BE DELAYED INDEFINITELY IF ANY APPEAL OF THE FINAL RESULTS IS FILED WITH THE COURT OF INTERNATIONAL TRADE.
