1. THE DEPARTMENT OF COMMERCE HAS RESCINDED THE NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER ON POTASSIUM PERMANGANATE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-001), COVERING THE PERIOD 01/01/2000 THROUGH 12/31/2000 AND THE EXPORTER/MANUFACTURER, GROUPSTARS CHEMICAL CO. LTD. (A-570-001-013).

THIS NOTICE OF RESCISSION WAS PUBLISHED IN THE FEDERAL REGISTER ON 06/03/2002 (67 FR 38254).

2. FOR SHIPMENTS OF POTASSIUM PERMANGANATE FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/03/2002, A CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING EXPORTER/MANUFACTURER:

GROUPSTARS CHEMICAL CO. LTD. A-570-001-013

3. WHEN THE NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER ON POTASSIUM PERMANGANATE FROM THE PEOPLE'S REPUBLIC OF CHINA WAS INITIATED, THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ASSIGNED GROUPSTARS CHEMICAL CO. LTD. ITS OWN COMPANY NUMBER IN THE MODULE (A-570-001-013). HOWEVER, BECAUSE THE NEW SHIPPER REVIEW HAS BEEN RESCINDED, THE DEPARTMENT DID NOT CALCULATE A FINAL COMPANY-SPECIFIC CASH DEPOSIT RATE FOR GROUPSTARS CHEMICAL CO. LTD. THEREFORE, THE CASH DEPOSIT RATE FOR GROUPSTARS CHEMICAL CO. LTD. CONTINUES TO BE THE PRC-WIDE RATE (A-570-001-000). THIS RATE IS CURRENTLY 128.94 PERCENT.
