RE: PRELIMINARY INJUNCTION ON CRAWFISH FROM CHINA (A-570-848)

1. ON JUNE 26, 2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING THE DEPARTMENT OF COMMERCE FROM APPLYING THE CASH DEPOSIT RATE, AS DETERMINED BY COMMERCE IN THE FINAL RESULTS OF ANTIDUMPING DUTY ADMINISTRATIVE REVIEW AND FINAL PARTIAL RESCISSION OF ANTIDUMPING DUTY ADMINISTRATIVE REVIEW OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR EXPORTS BY HFTC(5) (AKA JIANGSU HILONG INTERNATIONAL TRADING COMPANY LTD.) (A-570-848-034),

ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER

APRIL 22, 2002. THESE SHIPMENTS MIGHT ALSO HAVE BEEN ENTERED UNDER A-570-848-000.

2. IN ACCORDANCE WITH THIS PRELIMINARY INJUNCTION, THE TEMPORARY RESTRAINING ORDER ISSUED BY THE COURT IS DISSOLVED. SEE MESSAGE NUMBER 2154224, DATED JUNE 3, 2002, "NOTIFICATION OF TEMPORARY RESTRAINING ORDER (TRO) ON FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD SEPTEMBER 1, 1999 THROUGH AUGUST 31, 2000 (A-570-848)." UNTIL FURTHER NOTICE, THE REQUIRED CASH DEPOSIT RATE FOR ENTRIES OF SUBJECT MERCHANDISE EXPORTED BY HFTC(5) (AKA JIANGSU HILONG INTERNATIONAL TRADING COMPANY LTD.), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER APRIL 22, 2002, WILL CONTINUE TO REMAIN AT 2.75 PERCENT.
