ALL SALES OF ARGENTINE CARBON STEEL WIRE ROD DURING THE
PERIOD NOVEMBER 1, 1988 THROUGH OCTOBER 31, 1989, AND
EXPORTED TO THE UNITED STATES BY ACINDAR INDUSTRIA
ARGENTINA DE ACEROS S.A. ("ACINDAR"), ARGENTINA, ARE FREE
OF DUMPING LIABILITY. APPRAISE SUCH SHIPMENTS AND
LIQUIDATE THE APPLICABLE ENTRIES BY STAMPING THE INVOICES
WITH THE WORDING "NO DUMPING DUTIES DUE".

IMMEDIATELY FORWARD TO CUSTOMS SERVICE HEADQUARTERS ANY INFORMATION ON FILE WHICH MIGHT AFFECT THE APPRAISED VALUES UNDER THE ANTIDUMPING PROVISIONS, WITH AN EXPLANATION OF THE CIRCUMSTANCES UNDER WHICH IT WAS RECEIVED. IN SUCH A CASE, SUSPEND LIQUIDATION OF THE AFFECTED ENTRIES UNTIL A DECISION IS MADE CONCERNING THE APPLICABILITY OF THE ADDITIONAL INFORMATION.

THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 AS AMENDED, WHICH REQUIRE INTEREST ON OVERPAYMENTS AS UNDERPAYMENTS OF THE AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE RATE AT WHICH SUCH INTEREST IS PAYABLE FOR ANY PERIOD IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION ONLY.

YOU MAY RELEASE APPRAISED VALUES TO THE INDIVIDUAL IMPORTER CONCERNED OR HIS AUTHORIZED REPRESENTATIVE. YOU MAY NOT RELEASE ANY DETAILS OF THE CALCULATIONS OF APPRAISED VALUES WITHOUT AUTHORIZATION OF CUSTOMS SERVICE HEADQUARTERS.

EFFECTIVE AS OF THE DATE OF INSUANCE OF THIS MATTER LIST BY THE C.I.E., YOU SHOULD NO LONGER SUSPEND LIQUIDATION OF THE ENTRIES COVERED BY THIS MASTER LIST AND YOU SHOULD PROCEED WITH LIQUIDATION ACCORDINGLY.
