1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (67 FR 40912) ON 06/14/2002 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT

TO THE ANTIDUMPING DUTY ORDER ON EXTRUDED RUBBER THREAD FROM INDONESIA FOR THE PERIOD 05/01/2000 THROUGH 04/30/2001.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF EXTRUDED RUBBER THREAD FROM INDONESIA FOR THE PERIOD ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/14/2002, A REVISED CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS IN THE AMOUNTS SHOWN BELOW:
