1. ON 07/01/2002, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS COUNTERVAILING DUTY ORDER IN THE INVESTIGATION OF PET FILM FROM INDIA (67 FR 44179).

2. FOR PURPOSE OF THIS ORDER THE PRODUCTS COVERED ARE ALL GAUGES OF RAW, PRETREATED, OR PRIMED PET FILM, WHETHER EXTRUDED OR COEXTRUDED. EXCLUDED ARE METALLIZED FILMS AND OTHER FINISHED FILMS THAT HAVE HAD AT LEAST ONE OF THEIR SURFACES MODIFIED BY

THE APPLICATION OF A PERFORMANCE-ENHANCING RESINOUS OR INORGANIC LAYER OF MORE THAN 0.00001 INCHES THICK. IMPORTS OF PET FILM ARE CLASSIFIABLE IN THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS) UNDER ITEM NUMBER 3920.62.00. HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES. THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS ORDER IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER C-533-825.

4. ENTRIES OF PET FILM MADE ON OR AFTER 02/19/2002, AND PRIOR TO 07/01/2002, THE DATE OF PUBLICATION OF THIS ORDER IN THE FEDERAL REGISTER, ARE NOT LIABLE FOR THE ASSESSMENT OF COUNTERVAILING DUTIES DUE TO THE DEPARTMENT'S DISCONTINUATION, EFFECTIVE 02/19/2002, OF SUSPENSION OF LIQUIDATION, PURSUANT TO SECTION 703(d) OF THE ACT.

5. FOR IMPORTS OF PET FILM FROM INDIA, THE CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/22/2001, THE DATE OF PUBLICATION OF THE PRELIMINARY DETERMINATION IN THE FEDERAL REGISTER, THROUGH 02/18/2002. FOR IMPORTS OF PET FILM FROM INDIA, THE CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2002, THE DATE OF PUBLICATION OF THIS ORDER IN THE FEDERAL REGISTER. EFFECTIVE 07/01/2002 CUSTOMS SHALL REQUIRE A CASH DEPOSIT EQUAL TO THE SUBSIDY RATES SHOWN BELOW:
