THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON CARBON STEEL WIRE ROD FROM SAUDI ARABIA AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON APRIL 14, 1992 (57 FR 12910). THE REVIEW COVERS THE PERIOD JANUARY 1, 1990 THROUGH DECEMBER 31, 1990.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF SAUDI CARBON STEEL WIRE ROD. CARBON STEEL WIRE ROD IS A COILED, SEMI-FINISHED, HOT-ROLLED CARBON STEEL PRODUCT OF

APPROXIMATELY ROUND SOLID CROSS SECTION, NOT UNDER 0.20 INCH NOR OVER 0.74 INCH IN DIAMETER, TEMPERED OR NOT TEMPERD, TREATED OR NOT TREATED, NOT MANUFACTURED OR PARTLY MANUFACTURED, AND VALUED OVER OR UNDER FOUR CENTS PER POUND. SUCH MERCHANDISE IS CLASSIFIABLE UNDER ITEM NUMBERS 7213.20.00, 7213.31.30, 7213.31.60, 7213.39.00, 7213.41.30, 7213.41.60, 7213.49.00 AND 7213.50.00 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

3. ACCORDINGLY, FOR SHIPMENTS OF SAUDI WIRE ROD ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER APRIL 14, 1992, YOU SHALL WAIVE CASH DEPOSITS OF ESTIMATED COUNTERVAILING DUTIES FOR ALL MANUFACTURERS/EXPORTERS.
4. THIS WAIVING OF CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.

DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
