A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

5. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL APPRAISEMENT INSTRUCTIONS ARE RECEIVED.
