MAN-MADE FIBERS FROM JAPAN, MANUFACTURED BY MOMOI FISHNETTING
MANUFACTURING CO., LTD. (A-588-029-024) AND SOLD DURING THE

PERIOD JUNE 1, 1986 THROUGH MAY 31, 1987.
