1. THE DEPARTMENT OF COMMERCE PUBLISHED ON JULY 29, 1992, THE NOTICE OF ITS INITIATION OF THE ANTIDUMPING DUTY INVESTIGATIONS AND POSTPONEMENT OF PRELIMINARY DETERMINATIONS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS, CERTAIN COLD-ROLLED CARBON

STEEL FLAT PRODUCTS, CERTAIN CORROSION-RESISTANT STEEL FLAT PRODUCTS, AND CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM

VARIOUS COUNTRIES.

2. ONE OF THE FOUR CLASSES OR KINDS OF PRODUCTS COVERED BY THESE INVESTIGATIONS ARE CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE PRODUCTS. THESE PRODUCTS INCLUDE HOT-ROLLED CARBON STEEL UNIVERSAL MILL PLATES (I.E., FLAT-ROLLED PRODUCTS ROLLED ON FOUR FACES OR IN A CLOSED BOX PASS, OF A WIDTH EXCEEDING 150 MILLIMETERS BUT NOT EXCEEDING 1,250 MILLIMETERS AND OF A THICKNESS OF NOT LESS THAN 4 MILLIMETERS, NOT IN COILS AND WITHOUT PATTERNS IN RELIEF) OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, NEITHER CLAD, PLATED NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED, OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES; AND CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS IN STRAIGHT LENGTHS, OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, HOT ROLLED, NEITHER CLAD, PLATED, NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED, OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES, 4.75 MILLIMETERS OR MORE IN THICKNESS AND OF A WIDTH WHICH EXCEEDS 150 MILLIMETERS AND MEASURES AT LEAST TWICE THE THICKNESS, AS CURRENTLY CLASSIFIABLE IN THE HTS UNDER ITEM NUMBERS: 7208.31.0000, 7208.32.0000, 7208.33.1000, 7208.33.5000, 7208.41.0000, 7208.42.0000, 7208.43.0000, 7208.90.0000, 7210.70.3000, 7210.90.9000, 7211.11.0000, 7211.12.0000, 7211.21.0000, 7211.22.0045, 7211.90.0000, 7212.40.1000, 7212.40.5000, AND 7212.50.0000.
