1. THE DEPARTMENT OF COMMERCE PUBLISHED ON JULY 29, 1992, THE NOTICE OF ITS INITIATION OF THE ANTIDUMPING DUTY INVESTIGATIONS AND POSTPONEMENT OF PRELIMINARY DETERMINATIONS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS, CERTAIN COLD-ROLLED CARBON

STEEL FLAT PRODUCTS, CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS, AND CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM VARIOUS COUNTRIES.

2. ONE OF THE FOUR CLASSES OR KINDS OF PRODUCTS COVERED BY THESE INVESTIGATIONS ARE CERTAIN COLD-ROLLED CARBON STEEL FLAT PRODUCTS. THESE PRODUCTS INCLUDE (COLD-REDUCED) CARBON STEEL FLAT PRODUCTS OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, NEITHER CLAD, PLATED NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES, IN COILS, OR IN STRAIGHT LENGTHS WHICH, IF OF A THICKNESS LESS THAN 4.75 MILLIMETERS ARE OF A WIDTH MEASURING AT LEAST 10 TIMES THE THICKNESS OR IF OF A THICKNESS OF 4.75 MILLIMETERS OR MORE ARE OF A WIDTH WHICH EXCEEDS 150 MILLIMETERS AND MEASURES AT LEAST TWICE THE THICKNESS, AS CURRENTLY CLASSIFIABLE IN THE HTS UNDER ITEM NUMBERS:
