2. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL
REGISTER (67 FR 48612) ON 07/25/2002 THE FINAL RESULTS OF ITS
ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE
ANTIDUMPING ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S
REPUBLIC OF CHINA FOR THE PERIOD 12/01/1999 THROUGH 11/30/2000.

3. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER
