RE: Notice of preliminary determination in the countervailing duty investigation of certain frozen warmwater shrimp from the People's Republic of China (C-570-989)

1. On 06/04/2013, Commerce published in the Federal Register its affirmative preliminary determination in the countervailing duty investigation of certain frozen warmwater shrimp from the People's Republic of China (78 FR 33346).

2. The products covered by this investigation are described in message 3028305 dated 01/28/2013.

3. This investigation has been assigned investigation number C-570-989.

4. For imports of certain frozen warmwater shrimp from the People's Republic of China, CBP shall suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 06/04/2013. Effective 06/04/2013, CBP shall require, for such entries, a cash deposit equal to the subsidy rates for the companies listed below:
