THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON LAMB MEAT FROM NEW ZEALAND (C-614-503) AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON AUGUST 20, 1992 (57 FR 37772). THE REVIEW COVERS THE PERIOD APRIL 1, 1990 THROUGH MARCH 31, 1991.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF LAMB MEAT,

OTHER THAN PREPARED, PRESERVED OR PROCESSED FROM NEW ZEALAND.

DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBERS 0204.10.0000 0204.22.2000 0204.23.2000, 0204.30.0000, 0204.42.2000, AND 0204.43.2000 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

3. ACCORDINGLY, FOR SHIPMENTS OF LAMB MEAT FROM NEW ZEALAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER AUGUST 20, 1992, YOU SHALL COLLECT CASH DEPOSITS OF ESTIMATED COUNTERVAILING DUTIES AT ZERO PERCENT OF THE F.O.B. INVOICE PRICE FOR ALL COMPANIES.
4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
