1. ON 11/24/1997, THE U.S. COURT OF INTERNATIONAL TRADE (CIT) ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON FERROSILICON FROM BRAZIL (A-351-820), MANUFACTURED OR EXPORTED BY COMPANHIA BRASILEIRA CARBURETO DE CALCIO (CBCC)(A-351-820-001) AND COMPANHIA FERROLIGAS MINAS GERAIS-MINISLIGAS (MINISLIGAS) (A-351-820-004), FOR THE PERIOD 03/01/1995 THROUGH 02/29/1996.

THE DEPARTMENT PREVIOUSLY NOTIFIED CUSTOMS, IN MESSAGE 9288215, ( 10/15/1999), THAT IT WAS ENJOINED BY THE CIT FROM ORDERING LIQUIDATION OF CERTAIN UNLIQUIDATED FERROSILICON ENTRIES.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY COMPANHIA BRASILEIRA CARBURETO DE CALCIO (CBCC) AND COMPANHIA FERROLIGAS MINAS GERAIS-MINISLIGAS (MINISLIGAS) AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE

PERIOD 03/01/1995 THROUGH 02/29/1996. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
