RE: Temporary Restraining Order on polyethylene terephthalate film, sheet, and strip from the United Arab Emirates (A-520-803), court number 13-00211

1. On 06/05/2013 the U.S. Court of International Trade issued a Temporary Restraining Order (TRO) enjoining liquidation of certain entries of merchandise which were produced and/or exported by JBF RAK LLC, which were subject to Polyethylene Terephthalate Film, Sheet, and Strip from the United Arab Emirates; Final Results of Administrative Review; 2010-2011 (78 FR 29700, 05/21/2013) and which entered during the period 11/01/2010 through 10/31/2011.
2. This TRO was issued in connection with court case number 13-00211 and enjoins liquidation of the entries described above. This TRO shall be effective for all entries which remain unliquidated as of 06/05/2013 and shall remain in effect until 06/20/2013.
3. Liquidation instructions for entries affected by the TRO have not yet been issued.
4. Accordingly, effective 06/05/2013 and until 06/20/2013, CBP is instructed not to liquidate entries of merchandise subject to the TRO as described in paragraph 1. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of other entries of polyethylene terephthalate film, sheet, and strip from the United Arab Emirates that were produced and/or exported by JBF RAK LLC and that were entered, or withdrawn from warehouse, for consumption during the period 11/01/2010 through 10/31/2011 until liquidation instructions are issued.
