1. UPON REVIEW OF THE RECORD IN THE ABOVE CASE, THE DEPARTMENT OF COMMERCE (COMMERCE) IS PROVIDING THE FOLLOWING AS GUIDANCE TO THE CUSTOMS SERVICE.

2. ON 04/24/2001, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON DRAMS FROM KOREA (A-580-812), MANUFACTURED OR EXPORTED BY COMPANHIA BRASILEIRA CARBURETO DE CALCIO (CBCC)(A-351-806-001)

AND ELETROSILEX BELO HORIZONTE (A-351-806-003), FOR THE PERIOD 07/01/1998 THROUGH 06/30/1999.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY COMPANHIA BRASILEIRA CARBURETO DE CALCIO (CBCC)(A-351-806-001) AND ELETROSILEX BELO HORIZONTE (A-351-806-003) AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE

PERIOD 07/01/1998 THROUGH 06/30/1999. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
