RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827)

1. ON 08/12/2002, IN RESPONSE TO A REQUEST BY BARTHCO TRADE CONSULTANTS, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT CYBERFLEX PENCILS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN CASED PENCILS (PENCILS) FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-827).

2. BECAUSE THE IMPORTED PRODUCT HAS A CORE OF GRAPHITE THAT IS ENCASED IN A SEMI-SOFT BARREL OF MAN-MADE MATERIAL (PLASTIC) WHICH IS DECORATED ITS FULL LENGTH WITH GEOMETRIC PATTERNS AND IS

TIPPED WITH AN ERASER AND FERRULE, AND BECAUSE THE CYBERFLEX PENCIL CAN BE SHARPENED AND CAN BE USED TO WRITE ON PAPER, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PENCILS FROM THE PRC, INCLUDING BARTHCO'S CYBERFLEX PENCIL (IMPORTED BY RAYMOND GEDDES & CO., INC.) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PENCILS FROM THE PRC.
