RE: PERMANENT COURT INJUNCTION ENJOINING THE LIQUIDATION OF INDUSTRIAL PHOSPHORIC ACID FROM ISRAEL (A-508-604)

1. PURSUANT TO AN ORDER OF THE COURT OF APPEALS FOR THE FEDERAL CIRCUIT IN CASE NUMBER 92-1366, DATED AUGUST 27, 1992, THE DEPARTMENT OF COMMERCE ("DEPARTMENT") AND U.S. CUSTOMS HAS BEEN ENJOINED FROM LIQUIDATING ANY ENTRIES OF INDUSTRIAL PHOSPHORIC ACID FROM ISRAEL EXPORTED BY NEGEV PHOSPHATES, LTD. ("NEGEV") (A-508-604-001) FOR THE PERIOD AUGUST 1, 1989 THROUGH JULY 31, 1990, AS WELL AS ALL ENTRIES ENTERED AFTER THAT PERIOD BY EITHER NEGEV OR ROTEM FERTILIZERS, LTD. (A-508-604-003)

2. AS A RESULT, THE COURT'S TEMPORARY ORDER, DATED JULY 14, 1992, AND FORWARDED TO U.S. CUSTOMS ON JULY 22, 1992, ENJOINING LIQUIDATION OF THE ABOVEMENTIONED ENTRIES IS NOW PERMANENT.
3. BECAUSE OF THIS ORDER, U.S. CUSTOMS IS PROHIBITED FROM LIQUIDATING THESE ENTRIES UNTIL FURTHER INSTRUCTED BY THE DEPARTMENT. THEREFORE DISREGARD INSTRUCTIONS #2164111 DATED JUNE 12, 1992, AS THEY RELATE TO NEGEV, AND DO NOT LIQUIDATE ENTRIES FOR NEGEV OR ROTEM FERTILIZIERS, LTD. UNTIL FURTHER INSTRUCTED BY THE DEPARTMENT.
