THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF NMB/PELMEC'S AFB ENTRIES DURING THE PERIOD NOVEMBER 9, 1988 THROUGH APRIL 30, 1990 SUBJECT TO THE ANTIDUMPING DUTY ORDER ON ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM THAILAND.

2. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER

BEARINGS) AND PARTS THEREOF FROM THAILAND THAT WERE PRODUCED BY NMB/ PELMEC (UNLESS EXPORTED BY AN OEM) OR EXPORTED BY NMB/ PELMEC AND THAT WERE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD NOVEMBER 9, 1988 THROUGH APRIL 30, 1990.
