THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF CERTAIN AFB ENTRIES DURING THE PERIOD NOVEMBER 9, 1988 THROUGH APRIL 30, 1990, SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM ITALY, AND EXPORTED OR MANUFACTURED BY THE COMPANIES LISTED BELOW.

2. IN CERTAIN CASES, THE INJUNCTION ONLY COVERS BALL BEARINGS.

THIS IS INDICATED BY PARENTHESES NEXT TO THAT PARTICULAR FIRM'S NAME. ANY ENTRIES FROM THESE FIRMS WHICH INCLUDE ANY BALL BEARINGS ARE COVERED BY THE COURT INJUNCTION.

3. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF ANTI-FRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM ITALY THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD NOVEMBER 9, 1988 THROUGH APRIL 30, 1990 AND THAT WERE PRODUCED OR EXPORTED BY THE FOLLOWING FIRMS, UNLESS EXPORTED BY AN UNLISTED OEM:

FIATAVIO (BALL BEARINGS ONLY)

JAPANESE AERO ENGINES CORP. (BALL BEARINGS ONLY)

4. WITH RESPECT TO ENTRIES OF REVIEWED FIRMS NOT COVERED BY AN INJUNCTION, APPRAISEMENT INSTRUCTIONS HAVE ALREADY BEEN ISSUED, OR WILL BE FORTHCOMING. IF YOU HAVE NOT YET RECEIVED APPRAISEMENT INSTRUCTIONS FOR THESE ENTRIES, CONTINUE TO SUSPEND LIQUIDATION UNTIL SPECIFIC APPRAISEMENT INSTRUCTIONS ARE ISSUED.
