1. THE DEPARTMENT OF COMMERCE IS CONDUCTING A NEW SHIPPER
ADMINISTRATIVE REVIEW OF THE ANTIDUMPING ORDER ON HONEY FROM THE
PEOPLE'S REPUBLIC OF CHINA (A-570-863) FOR THE PERIOD 12/01/2001
THROUGH 05/31/2002.

2. THE NOTICE OF INITIATION OF THE NEW SHIPPER REVIEW WAS
PUBLISHED IN THE FEDERAL REGISTER ON 08/06/2002 (67 FR 50862).

3. IN ACCORDANCE WITH SECTION 351.214(E) OF THE COMMERCE DEPARTMENT'S REGULATIONS, FOR SHIPMENTS OF HONEY FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE UNITED STATES ON OR AFTER 08/06/2002, A BOND OR OTHER SECURITY DEPOSIT IS PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING NEW MANUFACTURERS AND/OR EXPORTERS:

IN ACCORDANCE WITH T.D. 85-145, AT THE DISCRETION OF THE CUSTOMS SERVICE, CUSTOMS OFFICERS MAY ACCEPT EITHER A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND OR A CONTINUOUS BASIC IMPORTATION AND ENTRY BOND ONLY IF THE AMOUNT OF THE ESTIMATED ANTIDUMPING OR COUNTERVAILING DUTY IS LESS THAN FIVE PERCENT AD VALOREM (OR TH EQUIVALENT). OTHERWISE, WHERE THE IMPORTER HAS THE OPTION TO POST A BOND FOR ESTIMATED ANTIDUMPING OR COUNTERVAILING DUTIES, CUSTOMS OFFICERS MUST REQUIRE A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND PURSUANT TO T.D. 85-145. YOU ARE INSTRUCTED TO ADHERE TO THE REQUIREMENTS OF T.D. 85-145 WITH RESPECT TO THESE BONDING REQUIREMENTS.

5. FOR ALL OTHER COMPANIES NAMED IN THE ANTIDUMPING DUTY MODULE, THE CASH DEPOSIT RATE IS THE RATE PROVIDED THEREIN.

6. FOR ALL OTHER CHINESE MANUFACTURERS/EXPORTERS OF HONEY WHICH DO NOT HAVE A SPECIFIC RATE IN THE MODULE, THE CASH DEPOSIT RATE CONTINUES TO BE 183.80 PERCENT.

7. THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT WILL REMAIN IN EFFECT FOR EXPORTS FROM DUBAO AND WUHAN UNTIL PUBLICATION OF THE FINAL RESULTS OF THIS NEW SHIPPER ADMINISTRATIVE REVIEW.
