RE: SCOPE RULING ON BALL BEARINGS AND CYLINDRICAL ROLLER BEARINGS, AND PARTS THEREOF FROM ITALY

1. ON MAY 18, 1992, IN RESPONSE TO A REQUEST BY IBC BEARING CO., INC., (IBC), THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ISSUED A FINAL SCOPE RULING THAT THE STAINLESS STEEL BALLS (SSBS) IMPORTED BY IBC ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDERS ON BALL BEARINGS AN CYLINDRICAL ROLLER BEARINGS, AND PARTS THEREOF FROM ITALY.

2. THE SSBS IMPORTED BY IBC ARE NOT WITHIN THE SCOPE OF THE ORDERS BECAUSE THEY ARE FINISHED SEMIGROUND BALLS, WHICH ARE

SPECIFICALLY EXCLUDED FROM THE SCOPE OF THE ORDERS.

3. EFFECTIVE IMMEDIATELY, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES, REGARDLESS OF ENTRY DATE, OF THE ABOVE LISTED PRODUCTS.

4. REFUND ANY CASH DEPOSITS AND RELEASE ANY BONDS RELATING TO THE ABOVE LISTED PRODUCTS.

5. IN ACCORDANCE WITH PREVIOUS INSTRUCTIONS, CONTINUE TO SUSPEND LIQUIDATION OF BALL BEARINGS AND CYLINDRICAL ROLLER BEARINGS, AND PARTS THEREOF FROM ITALY.
