1. CUSTOMS INFORMED COMMERCE THAT IT HAD RECEIVED ENTRIES FOR WHICH THE MANUFACTURER WAS LISTED AS "GMN PAUL MULLER INDUSTRIE GmbH GERMANY." SINCE CUSTOMS MAINTAINS SEPARATE CASH DEPOSIT RATES FOR BOTH GMN AND PAUL MULLER IT REQUESTED THAT COMMERCE CLARIFY WHETHER THESE ENTRIES SHOULD BE SUSPENDED AT GMN 'S CASH-DEPOSIT RATE OR AT PAUL MULLER'S CASH-DEPOSIT RATE.

2. PURSUANT TO CUSTOMS' REQUEST, COMMERCE CONCLUDED FROM THE

EVIDENCE ON THE RECORD THAT PAUL MULLER ESSENTIALLY IS GMN FOR THE PURPOSES OF FUTURE ENTRIES. THEREFORE, CUSTOMS IS HEREBY INSTRUCTED TO COLLECT ESTIMATED ANTIDUMPING DUTIES ON ENTRIES OF BALL BEARINGS FROM GERMANY FOR WHICH THE MANUFACTURER IS LISTED AS "GMN PAUL MULLER" AT THE CASH-DEPOSIT RATE ESTABLISHED FOR PAUL MULLER.
