1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON LEATHER WEARING APPAREL AND PARTS AND PIECES THEREOF FROM URUGUAY FOR THE PERIOD JANUARY 1, 1990 THROUGH DECEMBER 31, 1991. THEREFORE, RELEVANT ENTRIES ARE TO BE LIQUIDATED AT THE RATE OF CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY.

2. IMPORTS COVERED BY THESE INSTRUCTIONS ARE SHIPMENTS OF

LEATHER WEARING APPAREL AND PARTS AND PIECES THEREOF FROM URUGUAY. DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBERS 4203.10.4030, 4203.10.4060 AND 4203.10.4090 OF THE HARMONIZED TARIFF SCHEDULES.

3. IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT A RATE EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON MERCHANDISE EXPORTED, ON OR AFTER JANUARY 1, 1990 AND ON OR BEFORE DECEMBER 31, 1991.

4. THE RATES OF ESTIMATED COUNTERVAILING DUTIES WHICH WERE REQUIRED TO BE DEPOSITED ARE:

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1990 AND ON OR BEFORE DECEMBER 31, 1991 IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1992 WILL CONTINUE.
  
6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
