1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER ON 09/12/2002, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON AXES/ADZES FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 02/01/2000 THROUGH 01/31/2001.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF AXES/ADZES FROM THE PEOPLE'S REPUBLIC OF CHINA
