ON 09/25/2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827), EXPORTED BY KAIYUAN GROUP CORPORATION FOR THE PERIOD 12/01/1999 THROUGH 11/30/2000.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS EXPORTED BY KAIYUAN GROUP

CORPORATION AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE,  
FOR CONSUMPTION DURING THE PERIOD 12/01/1999 THROUGH 11/30/2000.  
CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL  
LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE  
SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
