1. THE DEPARTMENT OF COMMERCE HAS COMPLETED THE ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON VISCOSE RAYON STAPLE FIBER FROM SWEDEN AND PUBLISHED THE NOTICE IN THE FEDERAL REGISTER ON APRIL 14, 1992 (57 FR 12912) FOR THE PERIOD JANUARY 1, 1990 THROUGH DECEMBER 31, 1990.

2. IMPORTS COVERED BY THESE INSTRUCTIONS ARE SHIPMENTS OF SWEDISH REGULAR VISCOSE RAYON STAPLE FIBER AND HIGH-WET

MODULUS (MODAL) VISCOSE RAYON STAPLE FIBER. SUCH MERCHANDISE IS CLASSIFIABLE UNDER ITEM NUMBER 5504.10.00 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

3. ACCORDINGLY, FOR SHIPMENTS OF SWEDISH VISCOSE RAYON STAPLE FIBER ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER APRIL 14, 1992, YOU ARE TO COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES EQUAL TO THE AMOUNT LISTED BELOW FOR THE MANUFACTURER/EXPORTER NOTED:
