FROM TURKEY

1. THESE LIQUIDATION INSTRUCTIONS COVER ALL ENTRIES OF ACETYLSALICYLIC ACID (ASPIRIN) FROM TURKEY UPON WHICH LIQUIDATION HAS BEEN SUSPENDED, FROM THE TIME OF THE PRELIMINARY DETERMINATION, MARCH 3, 1987 THROUGH DECEMBER 1, 1990.

2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE SHIPMENTS OF ACETYLSALICYLIC ACID (ASPIRIN) FROM TURKEY, CONTAINING NO ADDITIVES OTHER THAN INACTIVE SUBSTANCES (SUCH AS STARCH,

LACTOSE, CELLULOSE, OR COLORING MATERIAL), AND/OR ACTIVE SUBSTANCES IN CONCENTRATIONS LESS THAN THAT SPECIFIED FOR PARTICULAR NON-PRESCRIPTION DRUG COMBINATIONS OF ASPIRIN AND ACTIVE SUBSTANCES AS PUBLISHED IN THE HANDBOOK OF NON-PRESCRIPTION DRUGS, 8TH EDITION, AMERICAN PHARMACEUTICAL ASSOCIATION, AND IS NOT IN TABLET, CAPSULE OR SIMILAR FORMS FOR DIRECT HUMAN CONSUMPTION. THIS PRODUCT WAS PREVIOUSLY CLASSIFIED UNDER ITEM 410.72 OF THE TARIFF SCHEDULES OF THE UNITED STATES (TSUS), AND IS CURRENTLY CLASSIFIED UNDER ITEM NUMBER 2918.22 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

3. IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF, OR BOND FOR, ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON THE SUBJECT MERCHANDISE FOR THE FOLLOWING PERIODS.

THE SUSPENSION OF LIQUIDATION ORDERED FOR SHIPMENTS OF THIS MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MARCH 3, 1987 AND EXPORTED ON OR BEFORE DECEMBER 31, 1990 IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THIS MERCHANDISE (EXCEPT THAT PRODUCED AND EXPORTED BY PROSES KIMYA SANAYI VE TICARET A.S. (PROSES)), EXPORTED ON OR AFTER JANUARY 1, 1991 WILL CONTINUE. YOU ARE TO CONTINUE TO COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES AT THE CURRENT RATE OF 6.54 PERCENT OF THE F.O.B. INVOICE PRICE ON ALL SHIPMENTS OF THE SUBJECT

MERCHANDISE EXCEPT THAT PRODUCED AND EXPORTED BY PROSES.
PROSES IS NOT SUBJECT TO THIS ORDER.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
7. ENTRIES BETWEEN THE DATES OF THE PRELIMINARY DETERMINATION AND PUBLICATION OF THE COUNTERVAILING DUTY ORDER ARE NOT SUBJECT TO THE INTEREST PROVISIONS OF SECTION 778. THEREFORE, NO INTEREST SHOULD BE COLLECTED OR PAID ON ENTRIES OR WITHDRAWALS MADE ON OR AFTER MARCH 3, 1987 AND ON OR BEFORE JULY 1, 1987.
