1. ON MARCH 31, 1992, IN RESPONSE TO A REQUEST BY WIN-TEX PRODUCTS, INC. (WIN-TEX), THE DEPARTMENT ISSUED A FINAL SCOPE RULING THAT THE SHOP TOWELS WIN-TEX IMPORTS FROM HONDURAS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER ON SHOP TOWELS OF COTTON FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC).

2. THE SHOP TOWELS ARE WITHIN THE SCOPE OF THE ORDER BECAUSE

THEY ARE SHOP TOWELS FROM THE PRC.

3. CONTINUE TO SUSPEND LIQUIDATION AND REQUIRE A CASH DEPOSIT OF ESTIMATED DUTIES, AT THE APPLICABLE RATE, OF ALL ENTRIES OF THE PRODUCTS LISTED IN PARAGRAPH 2, ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION.

4. IN ACCORDANCE WITH PREVIOUS INSTRUCTIONS, CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF SHOP TOWELS OF COTTON FROM THE PRC.
