ON SEPTEMBER 25, 2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON STAINLESS STEEL PLATE IN COILS FROM TAIWAN (A-583-830), MANUFACTURED OR EXPORTED BY YIEH UNITED STEEL CORPORATION OR EXPORTED BY TA CHEN STAINLESS PIPE CO., LTD. FOR THE PERIOD MAY 1, 2000 THROUGH APRIL 30, 2001.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES

OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY YIEH UNITED STEEL CORPORATION OR EXPORTED BY TA CHEN STAINLESS PIPE CO., LTD., AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 2000 THROUGH APRIL 30, 2001. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
