1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE REQUESTS FOR ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON STAINLESS STEEL WIRE ROD FROM SPAIN (C-470-004) FOR THE REVIEW PERIODS JANUARY 1, 1989 THROUGH DECEMBER 31, 1990.
2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS IS SPANISH STAINLESS STEEL WIRE ROD WHICH INCLUDES COILED, SEMI-FINISHED, HOT ROLLED STAINLESS STEEL PRODUCTS OF APPROXIMATELY ROUND SOLID CROSS SECTION, NOT UNDER 0.20 INCH

NOR OVER 0.74 INCH IN DIAMETER, WHETHER OR NOT TEMPERED OR TREATED OR PARTLY MANUFACTURED. THIS MERCHANDISE IS CURRENTLY CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE ITEM NUMBERS 7323.93.00 AND 9604.00.00.

3. THEREFORE, IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1990.

4. THE RATES OF ESTIMATED COUNTERVAILING DUTIES WHICH WERE REQUIRED TO BE DEPOSITED ARE:

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1991 IS LIFTED. LIQUIDATION INSTRUCTIONS FOR THE JANUARY 1, 1991 THROUGH DECEMBER 31, 1991 PERIOD WERE PREVIOUSLY ISSUED IN E-MAIL #2119112 DATED APRIL 28, 1992. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THE MERCHANDISE EXPORTED AFTER DECEMBER 31, 1991 WILL CONTINUE. YOU ARE TO CONTINUE TO WAIVE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
