1. The Department of Commerce has completed two administrative reviews of the countervailing duty order on industrial phosphoric acid from Israel and published the final results in the Federal Register on October 9, 1991 (56 FR 50854).
2. Imports covered by these reviews are shipments of industrial phosphoric acid from Israel.

This merchandise is currently classifiable under item number 2809.20.00 of the Harmonized Tariff Schedule.

3. Accordingly, for shipments of Israeli industrial phosphoric acid entered, or withdrawn from warehouse, for consumption on or after October 9, 1991, you shall collect a cash deposit of 11.26 percent of the f.o.b. invoice price.
4. These cash deposit requirements will remain in effect until publication of the final results of the next administrative review.

Do not liquidate any entries of this merchandise included in these administrative reviews until assessment instructions are received.
