1. The Department of Commerce has completed its administrative review of the countervailing duty order on live swine from Canada and published the final results in the Federal Register on October 7, 1991 (56 FR 50560).

2. Imports covered by this review are shipments of live swine from Canada. This merchandise is currently classifiable under item numbers 0103.91.00 and 0102.92.00 of the Harmonized

Tariff Schedule (HTS).

3. Accordingly, for shipments of Canadian live swine entered, or withdrawn from warehouse, for consumption on or after October 7, 1991 you shall collect cash deposits equal to the amounts listed below for the merchandise:

(1) Sows and Boars C-122-404-001 Can\$0.0049/lb.

(2) All Other Live Swine C-122-404-000 Can\$0.0932/lb.

4. These cash deposit requirements will remain in effect until publication of the final results of the next administrative review.

Do not liquidate any entries of this merchandise included in this administrative review until assessment instructions are received.
