1. ON OCTOBER 18, 2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN TIN MILL PRODUCTS FROM JAPAN (A-588-854), IMPORTED BY OKAYA (U.S.A.) INC. AND ENTERED THE UNITED STATES PRIOR TO AUGUST 1, 2001.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF

SUBJECT MERCHANDISE WHICH WAS IMPORTED BY OKAYA (U.S.A.) INC. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION PRIOR TO AUGUST 1, 2001 AND REMAIN UNLIQUIDATED AS OF 5PM ON OCTOBER 22, 2002. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
