1. The Department of Commerce has published its final determinations regarding its 1988 and 1989 administrative reviews in the Federal Register on October 21, 1991, that benefits which constitute bounties or grants within the meaning of the countervailing duty law are being provided to manufacturers, producers or exporters in India of iron-metal castings.

ACTION:

2. U.S. Customs field officers should collect the following cash deposit of estimated countervailing duties on shipments of iron-metal castings entered, or withdrawn from warehouse, for consumption on or after October 21, 1991:
