THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER ON OCTOBER 3, 2002 (67 FR 62098) THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE COUNTERVAILING DUTY ORDER ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM FRANCE FROM JANUARY 1, 2000, THROUGH DECEMBER 31, 2000.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM FRANCE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER OCTOBER 3, 2002, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:
