1. The Department of Commerce published in the Federal Register on November 4, 1991, notice of its final determinations that coated groundwood paper (CGP) from Belgium, Finland, France, Germany, and the United Kingdom was being sold at less than fair value.

2. The International Trade Commission (ITC) notified the Commerce Department on December 11, 1991, of its determinations that such

sales at less than fair value did not injure the U.S. domestic producers of CGP.

ACTION;

3. Because of these negative injury determinations, the U.S. Customs Service shall discontinue suspension of liquidation. All estimated antidumping duties deposited on such entries shall be refunded and the appropriate bonds or other securities be released at the time of liquidation.

4. Discontinuation of suspension of liquidation is ordered for the following:
