2. IF ANY CUSTOMS IMPORT OFFICE HAS CONTRARY INFORMATION AND IS

SUSPENDING LIQUIDATION OF ENTRIES OF THIS MERCHANDISE EXPORTED FROM AUGUST 1, 1990 THROUGH SEPTEMBER 30, 1991, APPRAISING OFFICERS SHOULD NOTIFY THE OFFICE OF ANTIDUMPING COMPLIANCE, ROOM B-099, ITA, U.S. DEPARTMENT OF COMMERCE FORM ITA-356, WITHIN 30 DAYS OF RECEIPT OF THIS MESSAGE. NEGATIVE REPORTS ARE NOT REQUIRED.
