1. ON DECEMBER 13, 1991, THE U.S. COURT OF INTERNATIONAL TRADE (CIT) AFFIRMED THE DEPARTMENT OF COMMERCE'S AMENDED DETERMINATION

ON REMAND THAT THE DEPARTMENT SHOULD NOT HAVE REVOKED THE ORDER

IN 1981. IF THE CIT'S OPINION IN THIS CASE IS NOT APPEALED, OR IS AFFIRMED ON APPEAL, THEN AN ANTIDUMPING DUTY ORDER ON CLEAR PLATE AND FLOAT GLASS FROM JAPAN WILL BE REISSUED. IN THIS CASE, SUSPENSION OF LIQUIDATION MUST TAKE PLACE NO LATER THAN DECEMBER 23, 1991.

2. THEREFORE, EFFECTIVE IMMEDIATELY AND UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF THE ABOVE DESCRIBED MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION.

3. FOR ALL ENTRIES OF THIS MERCHANDISE, A CASH DEPOSIT OF ZERO PERCENT WILL BE REQUIRED.

4.
