ON 11/22/2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS, AND PARTS THEREOF, FINISHED AND UNFINISHED FROM JAPAN (A-588-604), PRODUCED AND/OR EXPORTED BY NTN CORPORATION (NTN), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/1993 THROUGH 09/30/1994.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY NTN

AND WHICH WERE ENTERED FOR CONSUMPTION, OR WITHDRAWN FROM WAREHOUSE, DURING THE PERIOD 10/01/1993 THROUGH 09/30/1994.
