1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON BRASS SHEET AND STRIP FROM FRANCE (C-427-603) FOR THE PERIODS JANUARY 1, 1989 THROUGH DECEMBER 31, 1990.
2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ON BRASS SHEET AND STRIP FROM FRANCE (C-427-603) IS DESCRIBED AS FRENCH BRASS SHEET AND STRIP, OTHER THAN LEADED BRASS AND TIN BRASS SHEET AND STRIP. THE PHYSICAL DIMENSIONS OF THE PRODUCTS ARE

BRASS SHEET AND STRIP OF SOLID RECTANGULAR CROSS SECTION OVER 0.006 INCHES (0.15 MILLIMETERS) THROUGH 0.188 INCHES (4.8 MILLIMETERS) IN FINISHED THICKNESSES OR GAUGE, REGARDLESS OF WIDTH. COIL, WOUND ON REELS (TRAVERSE WOUND), AND CUT-TO-LENGTH PRODUCTS ARE INCLUDED. THIS MERCHANDISE WAS CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE ITEM NUMBERS 7409.21.00 AND 7409.29.00 DURING THE APPLICABLE PERIOD.

3. THEREFORE, IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON BRASS SHEET AND STRIP FROM FRANCE EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1990.

4. THE RATE OF ESTIMATED COUNTERVAILING DUTIES WHICH WAS REQUIRED TO BE DEPOSITED IS:

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR FRENCH BRASS SHEET AND STRIP IS LIFTED WITH THESE INSTRUCTIONS FOR ENTRIES EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1990. LIQUIDATION INSTRUCTIONS FOR THE JANUARY 1, 1991 THROUGH DECEMBER 31, 1991 PERIOD WERE PREVIOUSLY ISSUED IN E-MAIL #2128113 DATED MAY 5, 1992. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF BRASS SHEET AND STRIP FROM FRANCE EXPORTED ON OR AFTER JANUARY 1, 1992 WILL CONTINUE.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS

DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
