1. ON 11/21/2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION (CONSOL. COURT NO. 99-08-00462) ENJOINING LIQUIDATION, DURING THE PENDENCY OF LITIGATION IN THE COURT OF APPEALS FOR THE FEDERAL CIRCUIT, OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON BALL BEARINGS (A-588-201), CYLINDRICAL ROLLER BEARINGS (A-588-203), AND SPHERICAL PLAIN BEARINGS (A-588-205) FROM JAPAN, MANUFACTURED OR EXPORTED BY NTN CORPORATION, FOR THE PERIOD 05/01/1997 THROUGH 04/30/1998 WHICH REMAIN UNLIQUIDATED AT THE

CLOSE OF BUSINESS ON 01/16/2003.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY NTN CORPORATION, OR IMPORTED INTO THE UNITED STATES BY ITS U.S. SUBSIDIARIES, AFFILIATES, AND ANY PARTIES RELATED THEREOF, AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/1997 THROUGH 04/30/1998 AND WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS ON 01/16/2002. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
