RE: SCOPE RULING ON CANDLES FROM CHINA (A-570-504)

1. ON DECEMBER 12, 2002, IN RESPONSE TO A REQUEST BY LEADER LIGHT, LTD. (LEADER LIGHT), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT LEADER LIGHT'S PALM OIL/PETROLEUM WAX " MOLDED" CANDLE (ITEM NO. C-3339-0), PALM OIL/PETROLEUM WAX " CRACKLE FINISH" CANDLE (ITEM NO. C-3775-0), "PEACE" MUSICAL CANDLES (ITEM NOS. C-0553-A AND C-0553-B), "HAPPY BIRTHDAY" MUSICAL CANDLES (ITEM NOS. C-0553-A AND C-0553-B), "SEASON'S GREETINGS" MUSICAL CANDLES (ITEM NOS. C-0553-A AND C-0553-B), " BRICK" CANDLES (ITEM NOS. C-0902-A, C-0902-B, C-0902-1-A, AND C-

0902-1-B), PILLAR CANDLE GIFT SET (ITEM NO. C-2594-0), STAR CANDLES (ITEM NO. C-2595-0), CERAMIC FILLED CANDLES (ITEM NO. C-2638-0), CANDLE GARDENS (ITEM NOS. C-2584-0-A AND C-2584-0-B), FLOATING CANDLES (ITEM NOS. C-2638-0-A, C-2638-0-B, C-2638-0-C, C-2638-0-D, AND C-2638-0-E), AND ARTIFICIAL FLOWER CANDLES (ITEM NOS. C-1495-A, C-1495-B, C-1495-C, AND C-1495-D) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS INCLUDE SHAPES SPECIFICALLY INCLUDED IN THE SCOPE OF THE ORDER OR DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER. ADDITIONALLY, REGARDING THE PALM OIL/PETROLEUM WAX CANDLES LISTED ABOVE, THE DEPARTMENT DID NOT FIND SUFFICIENT EVIDENCE ON THE RECORD TO ESTABLISH THAT THESE CANDLES SHOULD BE EXCLUDED BECAUSE OF THEIR PALM OIL CONTENT.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING PALM OIL/PETROLEUM WAX "MOLDED" CANDLE (ITEM NO. C-3339-0), PALM OIL/PETROLEUM WAX "CRACKLE FINISH" CANDLE (ITEM NO. C-3775-0), "PEACE" MUSICAL CANDLES (ITEM NOS. C-0553-A AND C-0553-B), "HAPPY BIRTHDAY" MUSICAL CANDLES (ITEM NOS.

A AND C-0553-B), "SEASON'S GREETINGS" MUSICAL CANDLES (ITEM NOS. C-0553-A AND C-0553-B), "BRICK" CANDLES (ITEM NOS. C-0902-A, C-

0902-B, C-0902-1-A, AND C-0902-1-B), PILLAR CANDLE GIFT SET (ITEM

NO. C-2594-0), STAR CANDLES (ITEM NO. C-2595-0), CERAMIC FILLED

CANDLES (ITEM NOS. C-1495-A, C-1495-B, C-1495-C, AND C-1495-D)

LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. FOR ALL SHIPMENTS OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE ABOVE-NOTED CANDLES IMPORTED BY LEADER LIGHT LISTED IN PARAGRAPH 1, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO ASSESS ANTIDUMPING DUTIES OF THE SUBJECT MERCHANDISE AS INSTRUCTED BY THE DEPARTMENT OF COMMERCE.
